

PREDIX T-SHIRT GIVEAWAY (“GIVEAWAY”) RULES

- 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN.**
- 2. Sponsor.** The Giveaway is sponsored by GE Digital LLC, located at 2623 Camino Ramon, San Ramon, CA 94583 (“GE”).
- 3. Eligibility Criteria.** The Giveaway is open to individuals who meet the following eligibility criteria: 1) must have registered as a developer on <https://www.predix.io/registration/>, 2) must have completed the guided tutorial at <http://go.digital.ge.com/predix-tshirt-welcome.html>, and 3) their pushed application must be live on Predix. Employees of GE and its affiliates, subsidiaries and parents and their immediate family members (spouse, parents, siblings, and children); household members of such employees; and users having existing Predix Developer Accounts or whose registrations have been rejected by GE are not eligible to participate in the Giveaway.
